WE'RE MAKING PROGRESS, BUT **DISCRIMINATION STILL HURTS.**

In the past year, some 1,200 individuals from member families (past and present) asked HSLDA for help when they were denied opportunities for education, careers, and financial support—just because they were homeschooled.

Your gifts helped us advocate for these members and, in the vast majority of cases, remove the obstacles unfairly placed in their paths.

It's a battle we've been fighting for 40 years.

Homeschool students have repeatedly proven themselves as successful students and contributing citizens. For example, homeschool graduates are routinely admitted to prestigious universities and accepted as top recruits by the military.

But as the conflicts of the last 12 months once again reveal, the principle that homeschoolers should be free to pursue the same possibilities as others has not filtered down to every crevice of government and private bureaucracy. The discrimination is real.

LIVELIHOOD UNDER ATTACK

One of the most egregious examples of discrimination occurred in California. Early in 2024 the state Department of Public Health revoked the licenses of two fully trained, fully qualified phlebotomists—based solely on the fact that the pair held homeschool high school diplomas. Officials falsely claimed that only graduates of an accredited high school can receive a license to draw blood.

It is true that California law requires an accredited high school diploma for anyone seeking a job in law enforcement. To satisfy this mandate, homeschoolers in the Golden State often take the California Proficiency Test (formerly Hi-SET) or obtain a GED.

But this rule does not apply to phlebotomy, which we pointed out to officials. We were proud to represent these two phlebotomists and were thrilled that their licenses were reinstated by the

California Department of Public Health. These two homeschool graduates are now in their chosen careers as licensed phlebotomists.

NO CHANCE FOR SCHOLARSHIPS

Homeschool students facing unlawful discrimination not only face difficult career choices, they also can be denied access to services. HSLDA helped reverse a decision in Georgia last year that prevented homeschooling students from taking a standardized test at public schools in the state's second most populated county.

The ban from accessing the exam at public schools posed a great difficulty for homeschooling families, whose only option was to seek out open slots at the few private academies offering the exam. Missing out on the test would also have meant foregoing the only way students can compete for education funds through the National Merit Scholarship Program. Those funds can total more than \$50,000 per student.

THERE OUGHT TO BE A LAW

Sometimes the battle for equal treatment requires a legislative solution. HSLDA worked with Virginia lawmakers this year to pass a bill solidifying access to military training for homeschool students. The bill ordered the Department of Education to notify local school boards of their obligations regarding access for homeschool students to the Junior Reserve Officers' Training Corps (JROTC).

The previous year we cited federal regulations to help a Virginia homeschool teen enroll in the JROTC program at his local public high school. Though the initial resistance to admit the student meant he started late in the term, the training and leadership skills he acquired in JROTC did make a difference in his application to the US Air Force Academy.

Now a homeschool graduate, the teen has accepted a scholarship to attend a one-year preparatory program this fall at Marion Military Institute in

Alabama. Upon completing the program, he should be a top candidate for entering the US Air Force Academy as a cadet.


FINANCIAL HARDSHIP

Discrimination can also be costly in financial terms. In the past year, HSLDA has represented dozens of families whose monthly payments were wrongfully terminated by various government agencies.

These situations typically involve students entitled to stipends through Social Security or Veterans Affairs. Officials at some state offices of these federal agencies mistakenly believe that homeschool students no longer qualify for payments once they turn 18. We show administrators that, like public school students, homeschool students who are still working toward their high school diplomas may receive payments until they turn 19.

Your support allows us to assist families in this area of advocacy—despite the court fees that sometimes pile up as our attorneys wrangle with bureaucrats who simply don't understand the law. This is where your generosity really makes a difference!

In one recent case, for example, we helped a Texas mother prove that her 18-year-old homeschool student really did qualify for continued child support payments despite taking part in the state's dual enrollment program. We successfully argued that under this program, courses taken at community college also count as high school credit.

It's been a busy and gratifying year as HSLDA continues to defend the freedom of homeschool students to follow their ambitions. With your help, we'll finally reach the day when graduates of home education encounter no hindrances to taking their place in any career field or educational pathway they choose. 

STANDING

with the Romeikes

After 15 years of living, working, and raising and homeschooling their children in the United States, the Romeike family's life was suddenly upended in September 2023 when they were informed they were no longer welcome here.

As asylum seekers, Uwe and Hannelore Romeike came to the United States in 2008 to escape persecution by German officials. The saga was precipitated by the Romeikes' decision to homeschool their children.

Germany had fined them beyond their means, forcibly taken their children to school, and threatened to remove their children from the home permanently. HSLDA assisted the family with an asylum application in the US.

An immigration judge's initial decision to grant asylum in 2010 was overturned by the US Board of Immigration Appeals in 2012. The Romeikes challenged that decision, and after years of legal

battles the family was granted "indefinite deferred action status" by the Department of Homeland Security in 2014.

The status allowed the Romeikes to build a life in the US. They were able to work, obtain driver's licenses, rent, own property, and pay taxes. They lived with this status for a decade.

During that time, Uwe and Hannelore put down roots in an eastern Tennessee community. The family found a church, where Uwe plays piano. Hannelore had two more children, who are American citizens by virtue of being born in the US. And two of their older children got married (to American citizens). Uwe also teaches music in the community and serves as a staff accompanist at a local university.

But all of that was threatened last September when the family reported to immigration authorities for an annual check-in. With no warning, the Romeikes

were told they had just a month to secure passports and begin self-deportation to Germany. They were given no explanation except that there had been a “change of orders.”

The family contacted HSLDA for help, and we were honored to respond. We organized legal and political responses on their behalf and launched a public awareness campaign.

Tennessee Representative Diana Harshbarger introduced a bill in Congress to grant them permanent residency, and thousands of homeschooling families contacted their representatives to urge them to support the bill. Our attorneys also advocated on their behalf in a wide variety of media outlets. And we asked the White House to intervene with a petition that racked up more than 118,000 signatures.

Just weeks after the initial order, the Romeikes were granted a one-year stay of deportation. Since then, 32 members of Congress have signed a letter asking committee leaders to advance the bill to grant the Romeikes the permanent residency status that will keep their family together.

These positive developments, and our ability to come alongside the Romeikes when they need us most, are only possible because of your support.

As we are preparing this publication for print, we are well aware that the one-year stay the Romeike family was granted last fall is nearing its end.

There is currently no indication that their status is going to be resolved in a permanent fashion, and we expect to continue to work on the family’s behalf to maintain their freedom to homeschool.

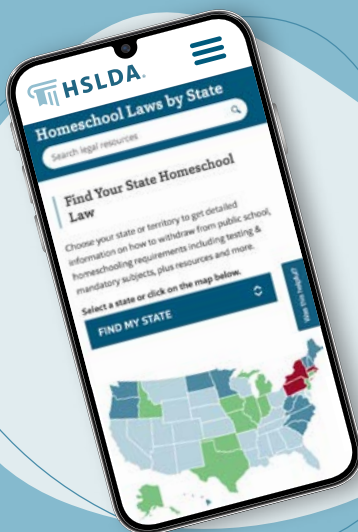

BRINGING COMPASSION AND HOPE

Your heart for families struggling to continue homeschooling through difficult circumstances enables us to provide essential support to hundreds of families and the groups that serve them.

Here's how we help:

- **Compassion Curriculum Grants** for single parents, widow(er)s, families homeschooling kids with special needs, military families, and others.
- **Compassion Disaster Relief Grants** for homeschooling families whose curriculum, home, or livelihood has been destroyed or damaged by a natural disaster or other act of God.
- **Financial Aid for HSLDA Membership** for families who need it.
- **Homeschool Group Grants** for local and state organizations to equip their families with better homeschooling resources and educational opportunities.

HEALING THROUGH HOMESCHOOLING: THE KING FAMILY'S STORY

When Scott and Jeanie King married, they dreamed of having a big family. But the path to achieving this dream ended up being different than they imagined. After raising and homeschooling three biological children to adulthood, Scott and Jeanie decided to pursue adoption.

In 2013, the Kings brought home and began to foster twin 1-year-old girls who had experienced much neglect. Helping these infants with developmental delays learn filled their lives with joy. Under Jeanie's gentle care, the baby girls—Eliana and Ariella—progressed dramatically, soon displaying signs of healthy 15-month-olds.

DEVASTATING NEWS

Not long after, however, the girls' family wanted them back. Losing the girls caused Scott and Jeanie so much anguish. But in retrospect, Jeanie sees how God allowed her and Scott to be their caretakers during a critical time in their development—learning to sit, crawl, stand, walk, and eat solid food.

As Scott pointed out, God had them foster the girls for a season, pouring into them so they knew what love was while their birth mother tried to rebuild her life.

FOSTERING AGAIN

After grieving the girls’ absence from their home, the Kings took in an 18-month-old baby girl who had been exposed to alcohol and drugs in utero and domestic violence after birth. **Doctors said Selah would never be able to read due to her mother’s substance abuse.**

Selah also had emotional walls. “We think Selah was frequently left alone in her playpen,” Jeanie explained. “She wouldn’t let me put her down for a nap in her crib or snuggle with her. She would just sit bolt upright in my lap. It took a long time for her to warm up to us.”

When Selah was 3, the Kings adopted her. Shortly after, Selah wanted a baby brother or sister! Scott and Jeanie prayed, and three years after Selah arrived, they welcomed home Solomon, a baby boy.

Early on, the Kings discovered Solomon was on the autism spectrum with hyperlexia, a condition characterized by precocious reading ability. **By age 2, Solomon was reading, despite no formal instruction.** “He just picked it up on his own,” Jeanie said. But he struggled with his emotions, so the Kings devoted a lot of time to helping him process his strong feelings in a healthy way.

REUNITING

Fast forward several years to 2021. Two days before Christmas, the twins' birth mother messaged Jeanie, asking them to take the girls back. "I'm so sorry that I ripped them away from you," she wrote. "I wish I had never done that. We've struggled ever since. Would you take them back for good?"

Seven long years had passed since Eliana and Ariella had left Scott and Jeanie. The Kings were now in their 50s and unsure whether they could handle two more children. But after the girls' grandmother informed them the twins would otherwise end up in foster care, they knew what to do. As the girls were nearly 8, finding a home for both of them would be difficult, and Jeanie worried about what would happen to the twins.

Besides, they had never stopped loving those girls!

Two weeks later, the Kings opened their arms to the girls once again. Six months later, the adoption was finalized, and Eliana and Ariella were now theirs to love... forever.

THE LIFE-GIVING POWER OF HOMESCHOOLING

When Selah neared school age, Jeanie had her evaluated by a psychologist, who recommended homeschooling. "If you send her to school, she won't get the focused attention she needs, and she'll be labeled as the bad child," the psychologist concluded. It was a clear answer from God for Jeanie, since the psychologist had no idea that she was already contemplating homeschooling.

Today, the family spends plenty of time engaging in a wide variety of activities—running around outside, working in the garden, and playing lots of hands-on learning and brain games to help their working memory, coordination, and ability to focus. **Jeanie reads to them constantly, and all of them can now read well—even Selah.**

A daily schedule adds stability, and healthy eating helps their minds function better. Weekly therapy for all four kids has also been a crucial component of their progress.

Observing all this a few years ago, a good friend asked Jeanie: "How can you afford all that? Did you know that HSLDA provides Curriculum Grants to families who are financially struggling?"

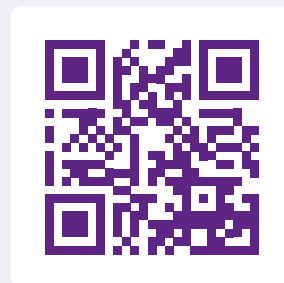
Jeanie was surprised, since she was unaware of the grants. "We'd struggled for years on just one income, often leaving home projects undone and better school materials off the table," she said. Jeanie reached out to HSLDA and applied for a Compassion Curriculum Grant, trusting that God would provide what they had been praying for, and He heard their prayers!

With the grant, the Kings were able to buy each child a tablet for their therapy exercises and schoolwork. And generous homeschool vendor discounts stretched their grant dollars even further.

"The grants are our miracle," Jeanie said. "We could never have afforded these materials that are dramatically helping our kids. Thank you, donors, for believing in homeschooling and wanting to bless another family like ours!" 🙏

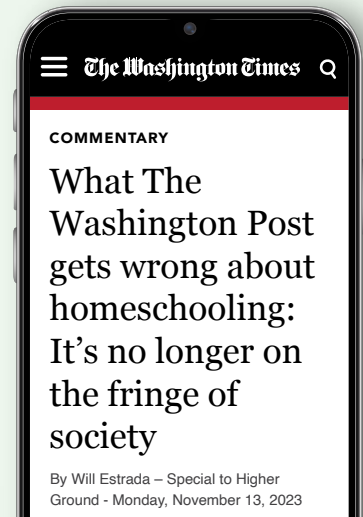

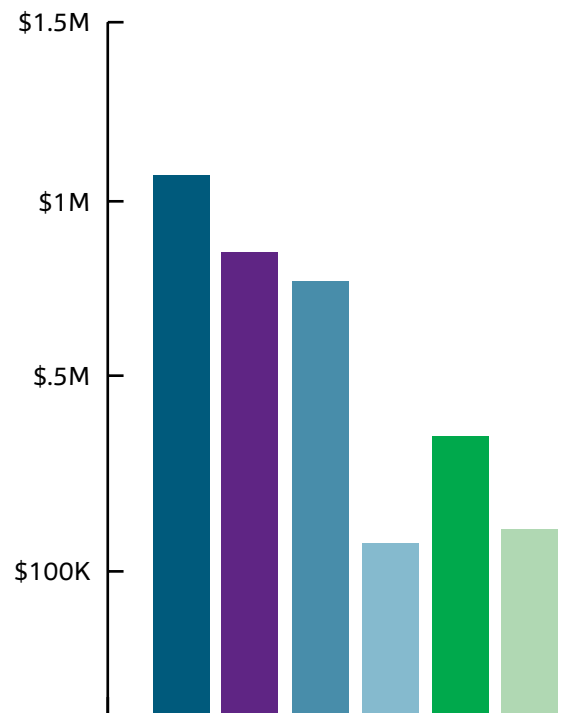
