




#### **US School-Age Children Being Homeschooled**

## US Households Homeschooling at Least One School-Age Child




#### **Expanding Diversity: Percent of Homeschool Households by Race**

Camila\* is from El Salvador but has lived in Virginia for more than 15 years. In the fall of 2021, Camila first noticed her daughter, Ana, was struggling to vocalize and pronounce letters. She asked Ana's teacher at the local public school if Ana could take a dyslexia test, but the school told Camila the test was unnecessary and promised Ana extra reading time. At three meetings during that year, the school told Camila that Ana was improving. Camila saw no improvement.

Less than a month after school began in September 2022, the school called Camila saying that Ana was suffering from serious stomach aches. Camila picked her up and noticed Ana was extremely frustrated and anxious.

"She kept crying and telling me she didn't want to go back to school," Camila said. "She panicked because she wasn't learning how to read as quickly and as well as other kids were, and on top of that, she was being bullied by another kid in her class."

Camila decided to withdraw Ana from public school. That same week, she became an HSLDA member and used HSLDA forms to file a letter of withdrawal and a notice of intent to both the school division and her city, Alexandria. She also attached a detailed home instruction program for Ana—one of the four ways parents can establish a homeschool program under Virginia law.

A couple of days after Camila filed her paperwork, a school social worker called and said Ana was considered truant and Camila could be taken to court unless Ana was in school the next day. The social worker advised Camila to attend a meeting with the school's attendance committee.

After a second social worker called Camila the following day, Camila called the school and was told that her paperwork was insufficient because she did not use the school division's forms and she did not submit a high school diploma.

Camila started to feel intimidated because she felt this harassment had to do with her Hispanic roots:

> At the start of the phone call, I asked if she could speak to me in Spanish because it is my preferred language.... At one point, the school employee said to me: 'I imagine you have a high school diploma, right?' I instantly knew she was doubting my instruction qualifications just because I felt more comfortable speaking Spanish.... I felt intimidated for being a Latina.

The next morning, Camila called HSLDA. Senior Counsel Scott Woodruff took her call, with help from one of our Spanish interpreters. He then sent a letter to the school representative expressing that Camila had submitted the paperwork legally.

"The law does not require that a family use any form when either withdrawing a child or filing a notice of intent and provides that a high school diploma



is not mandatory but is only one of four options for how a parent may qualify to provide home instruction," he wrote.

After Scott sent the letter, the school staff member called Camila and told her HSLDA lawyers were wrong and that they were only taking Camila's money. But after they received Scott's letter, Camila has not received any more calls or threats from the school.

Ana has been homeschooled since and has not exhibited any more anxiety symptoms. She's making progress in reading at her own pace and is no longer worried about encountering the classroom bully.

"She's more spontaneous, less timid. She likes to talk about what she's learning and feels more confident about herself," Camilla said, smiling.

It's because our donors stand with us to protect vulnerable single mothers like Camila that Ana was able to experience this amazing transformation.

As a homeschooling mother with young children, Jaimie GrosJacques found herself collecting typical things, like healthy recipes, storage solutions, and toddler craft ideas. But over the past few years, she found herself accumulating new resources—hospital stay checklists, tips for dealing with gastronomy tubes, and scriptures for handling pain and loss.

These items are tangible evidence of what the family has endured, reflecting an amalgamation of their life before and after. Their life the last few years bears little resemblance to Jaimie's husband Donny's homeschooling experience growing up. His childhood

memories played a large part in their decision to homeschool their own children, but neither Jaimie nor Donny had any idea how much the inherent flexibility of homeschooling would allow their family to adapt to life's challenges and ultimately bring them closer together as a family.

# HOMESCHOOLING FROM THE HOSPITAL

Their normal homeschooling routine of co-ops, projects, and playdates changed when Jaimie and

Donny's fourth child, Ilana, was born.

"We immediately saw that something was not right," Jaimie said. "She was blue. She wasn't breathing."

Ilana was rushed off to the NICU at a children's hospital where doctors discovered that the newborn had a hemangioma, a mass of blood vessels growing on her liver. It was causing congestive heart failure and preventing her lungs from filling with air. Suddenly, their life revolved around rounds of medical tests, surgeries, and feeding tubes. The condition and its resulting complications nearly killed little Ilana several times in her first few months.

"Homeschooling did look very different [for us] at that time," Jaimie recalled. "It was very basic."

The flexibility homeschooling offers took on vital new importance, allowing the GrosJacques family to spend as much time as possible with Ilana. School went with them to various medical facilities, with the kids working on whatever surface was available.

"We look back at the pictures sometimes... and [the kids] will be in the background, just sitting at a window reading their books," said Donny.

Homeschooling not only allowed for precious family time—it also gave the children a sense of normalcy during great emotional upheaval.

As the weeks wore on, Donny's parents, who lived near Ilana's hospital, invited the family to live at their house for as long as they needed. Through much prayer and good medical care, Ilana improved over time. Jaimie and Donny shifted out of crisis management and began their return to normal life.

## HOSPITAL HOMESCHOOLING, ROUND TWO

Then, out of the blue, Donny collapsed at work. He'd been struggling with some impaired vision and short-term memory loss but had chalked this up to getting older. He was rushed to the hospital where doctors found a tumor on his pituitary gland and two cysts pressing on his brain.

Donny underwent emergency brain surgery, throwing the family into another tumultuous season of healing and hospital visits. For six months, they simply lived day-to-day, allowing Donny's brain and body to recover.

After Donny's second surgery, the family was shocked to learn that their insurance no longer covered Donny's medications or the specialist that he needed to see for the rest of his life.

# NO LONGER ALONE: GRANT OFFERS HOPE AND COMMUNITY

But the very next day, she received an email from HSLDA, awarding the family a curriculum grant in response to an application she'd filled out.

"The grant has helped in so many ways! I can't look at my kids' school supplies... without remembering that kind gift and God's faithfulness," Jaimie shared.

This grant allowed the family to afford the curriculum they needed, which freed up funds for Donny's ongoing treatment. It also gave the family hope and a sense of community in the midst of their struggle.

The incredible impact the HSLDA Curriculum grant has had on the GrosJacques and many other families is only possible through the donations of our generous supporters.  $\P$

Thanks to you, we've been able to help even more families whose lives have been disrupted by unexpected circumstances.

Allison's\* family has been hit by a series of devastating events beginning with Hurricane Ida in 2021, leading them to reach out to HSLDA for a Compassion Grant in 2022. Ida had completely ruined this homeschooling single mom's rental home, including all her family's possessions and homeschool materials. In the wake of the destruction, she and her two children evacuated their home, leaving everything behind.

Thankfully, friends up north offered to let them stay with them until Allison and her children could find another place to live back in Florida.

Sadly, however, on their drive up to Pennsylvania, another disaster hit Allison and her kids. A woman who was texting while driving struck Allison's vehicle at 75 mph, catapulting the family's SUV over a guardrail, damaging the airbag sensors and preventing the airbags from deploying. Their SUV rolled over five times before it finally came to a stop.

As shocking as this latest catastrophe was, Allison realized that she felt God's complete peace. She shared what she experienced during the accident:

Two things kept us safe, seatbelts and Jesus. During the accident I felt no fear, despite hearing my daughter screaming, our dog howling and crying, and my son being eerily silent. All I saw was an army of angels surrounding us.

And all I heard was one, calm voice (I believe it was Jesus) telling me over and over, "You are going to be okay." I held onto the steering wheel, repeating that sentence over and over out loud so that my children would know His peace too.

Once out of the hospital, they made it to their friends' home, where because of their injuries, it took more than two months to recover enough to return to Florida. Unfortunately, Allison still suffers chronic back pain from the accident. Arriving back in Florida to an unlivable rental home full of fleas, mold, and water damage, Allison and her children had no place to go.

It was during this season of homelessness, while they were able to stay at their church for a short period of time, that Allison found out about HSLDA and applied for a Compassion Grant. As a single mother, temporarily without a job because of the car accident and temporarily without a home because of Hurricane Ida, Allison felt seen and cared for. Our donors' generosity made a world of difference for her.

Besides the devastation many homeschooling families are facing because of natural disasters, other crises—such as the loss of a job, diagnosis of a significant illness, or death of a spouse—are also threatening families' financial stability and stealing their peace of mind. Our donors have provided a helping hand reaching out to these families when they need it most. <sup>¶</sup>




